Artisan Vendor Instructions 2024

General:

• The Foss Farmers Market hours are Saturday, August 24th from 10am –3pm.

Load/Unload & Parking

- The Market is held on the Foss Village Green @ N 130th St. & 1st Ave. NW.
- It is recommended that you park on N 130th St. or 1st Ave. NW for best access to load and unload.

Setup and Break Down

- Set-up is Saturday, August 24th from 7:30am-9:30am.
- All booths need to be complete and ready by 9:30am.
- All vendors are responsible for bringing their own tables, tents, displays, etc.
- Break down begins at 3pm on Saturday, August 24th.
- All booths and merchandise must be removed by 4pm Saturday afternoon.

Sales

- Vendors are responsible for accepting payment for their own goods and merchandise.
- Foss does not take a percentage of vendor sales.
- Foss will be selling fresh produce at the Market. Customers take a produce receipt around to all of the produce booths and then check out at the Foss Cashier table.
- The Foss Cashier table will not accept payment for Vendor goods and merchandise.

Vendor Responsibilities

- Vendor is responsible for all security relative to Vendor's goods and merchandise during the Market, from the time of set-up until Vendor vacates the premises at the conclusion of the event.
- Vendor is also responsible for maintaining a clean/safe area during the event.

Restrooms

• Portable restrooms, including an ADA restroom, will be made available at the Market. Vendors and market attendees can use these restrooms.
